2. Certificate of reserved category/Physically Handicapped/ Minority (if any).
3. AADHAAR.

6. Affidavit of gap year (if any).
7. Character certificate from the last attended School/Institution/competent authority.
8. Domicile certificate of candidate passing the qualifying exam from out side Haryana.
9. In case of Kashmiri Migrant: Proof from a competent authority.
10. Medical Fitness Certificate (issued by Reg. medical Practitioner)
11. Certificate for COVID-19 Vaccination.
12. Anti Ragging Affidavits (by student & parents)
13. Student Information performa

***Original documents to be brought at the time of Counseling/Admission**

Note:

1. Candidate must fill the Application Form in his/her own handwriting with blue/black ball point pen.
2. While filling Application Form, candidate must fill the particulars as per details of Matriculation/Secondary School Certificate.
3. On admission, candidate will be required to deposit the fee for the session along with prescribed University/Board admission data management/counseling fee & will submit two sets of the attested copies of the above listed document(s) along with 5 recent passport size photographs in a self sealing transparent pouch.

Note: Paid fee of the session shall not be refunded on account of withdrawal of admission in between. No NOC shall be issued without the deposition of full fee for the session.

4. As per UGC/PCI/Board instructions, admitted candidates and their parents/guardians shall be required to submit the Anti Ragging Undertaking online on "http://antiragging.in/Site/Affidavits_registration_form.aspx" & submit the print out of the same in College.

Minimum Eligibility Conditions:

- For D. Pharmacy: Pass in 10+2 in Science Stream from recognized Board with atleast 50% marks.
- For B. Pharmacy: Pass in 10+2 in Science Stream from recognized Board with atleast 50% marks.
- For B. Pharmacy (Lateral Entry): Minimum 60% marks in D. Pharmacy from PCI approved Institutions.
- For M. Pharmacy: Minimum 55% in B. Pharmacy from PCI approved Institution.
